1. Background

The Intergovernmental Authority on Development (IGAD) is one of the eight Regional Economic Communities of the African Union, comprising the Member States of Djibouti, Ethiopia, Kenya, Somalia, South Sudan, Sudan and Uganda. It is home to more than 230 million people whose livelihoods and income are predominantly linked to agriculture. The IGAD region is one of the most diverse regions in the world, including areas of economic growth and investment on the one hand, and areas prone to violent conflict, political instability, humanitarian crises, and disasters linked to the adverse effects of climate change and environmental degradation on the other.

In the African continent, the IGAD region is considered one of the most vulnerable to climate variability and change and more than two thirds of the region are arid or semi-arid. It regularly faces a wide range of natural hazards leading to various forms of human mobility (displacement, migration and planned relocation), most commonly floods, but also landslides, and tropical cyclones, as well as slow-onset climate change effects, such as severe droughts, water level rise, environmental degradation, and changing rainfall variability.

The different forms of human mobility to, from, and within the IGAD region reflect the range of complex drivers and structural factors that can compel people to leave their places of origin. Disasters linked to natural hazards, environmental degradation, and the adverse effects of climate change are amongst the most important and overlapping drivers of human mobility. Individual migration decisions are often based on a combination of these environmental and other economic, political, social, and demographic drivers.

The implementation of planned and well-managed migration policies can have a positive contribution on development and protection of those moving or being compelled to move, the risk of which can be reduced or mitigated through regular pathways for migration, integrated approaches to disaster risk reduction, climate action and measures to support decent work and livelihoods and migration as an adaptation strategy.

The Participating United Nations Organizations (PUNOs): the International Organization for Migration (IOM), the International Labour Organization (ILO), the Platform on Disaster Displacement (PDD) (hosted under United Nations Office for Project Services (UNOPS)), and the United Nations High Commissioner for Refugees (UNHCR) and partners, the Intergovernmental Authority on Development (IGAD) Secretariat including the IGAD Climate Prediction and Application Centre (ICPAC) launched on 25 May 2021 the first regional Joint Programme "Addressing drivers and facilitating safe, orderly and regular migration in the context of disasters and climate change in the IGAD region", funded by the Migration Multi-Partner Trust Fund (MPTF).

The overall objective of this Joint Programme is to contribute to facilitating pathways for regular migration in the IGAD region and minimizing displacement risk in the context of climate change, environmental degradation and disasters in line with the vision and guiding principles of the Global Compact for Safe, Orderly and Regular Migration (GCM). In particular, the Joint-Programme aims to improve regional and national migration governance in the context of the adverse impacts of climate change and environmental degradation through different actions that each address the relevant objectives of the GCM and contribute to the implementation of other relevant international instruments,



Sustainable Development Goals, the 2015 Paris Agreement under the United Nation Framework Convention on Climate Change (UNFCCC) and the Sendai Framework for Disaster Risk Reduction 2015-2030.

The Joint Programme is conducting research and producing evidence in areas ranging from cross-border movements and international protection to the promotion of human mobility and the development of green economies in climate change and disaster-prone areas. Through the various interventions, the IGAD Member States will have better access to quality data and evidence on different forms of human mobility.

Under the Joint Programme collaboration is established with different stakeholders, such as UNFCCC Regional Collaboration Centre (RCC) in Kampala. The UNFCCC RCCs support national climate action in collaboration with local and regional agencies through capacity-building, technical assistance and strategic networking - sourcing know-how and resources to drive sustainable development. They were established to spread the benefits of the Clean Development Mechanism (CDM), which spurs investment in sustainable development by rewarding projects that reduce greenhouse gas emissions. Since the adoption of the Paris Agreement in December 2015, the RCCs have had the broader task of supporting implementation of the Agreement. Within this scope, RCCs use their network of global reach to catalyze, support, coordinate and accelerate participation and action by Parties and non-party stakeholders in the implementation of the Countries' Nationally Determined Contributions (NDCs), mobilization of finance and forging strategic partnerships for climate action.

In 2021, the UNFCCC secretariat and RCC Kampala in collaboration with International Development Research Center (IDRC) conducted a study on the capacity building gaps and needs of small and medium-sized enterprises (SMEs) to participate in climate action in East and Southern Africa. The study found that there is weak SME participation in climate policy formulation and low awareness of the policies. In addition, SMEs reported a need for more information on general impacts of climate change, as well as, need for technical and financial capacity building to respond. Notably many SMEs also voiced the need for partnerships, more accessible information and finances to enact climate proofing of enterprises. In addition to gaps and needs, the study mapped potential partnerships in the region. As a follow-up RCC Kampala is looking to disseminate the information, facilitate partnership development in the region and support the development of SME climate action capacity building programmes.

It is in this light that the partners will conduct consultative forums inviting participation from a wide range of stakeholders. These virtual consultative forums offer an opportunity for different stakeholders to seek synergies with on-going and future interventions and to identify partnership opportunities and priority areas of action in the intersection of human mobility, protection, green economy and climate change in supporting local, national and regional state actors in a coordinated manner.



2. Objective of the consultative forums

These virtual consultative forums aim at engaging a wide range of stakeholders in the IGAD region with knowledge, experience or interest in the intersection of human mobility, protection, green economy and climate change, who would be willing to share their views and perspectives.

The objective of the consultative forums is multi-fold;

- to take stock of lessons learnt and best practices of existing interventions implemented in the IGAD region related to human mobility and green economy (Session I);
- to validate the initial findings of the on-going studies by IOM/UNFCCC and UNHCR under the Joint Programme while at the same time seeking to collect further data for these studies through inputs from participants of these forums; and to discuss how to build on existing studies in the IGAD region (Session II);
- to discuss partnerships with academia, private sector actors, employers organizations and trade unions in enhancing climate action in the IGAD region (Session III);
- to enhance dialogue, establish synergies and partnerships among stakeholders addressing challenges and opportunities facilitating regular migration pathways, promoting sustainable development and green economy in the context of disasters, environmental degradation and climate change in the IGAD region, in line with the vision and guiding principles of the GCM (Sessions I-III).

3. Outcomes expected from consultative forums

- increased understanding on the effectiveness and efficiency of programming on green economy and human mobility in the region;
- initial IOM/UNFCCC and UNHCR study findings under the Joint Programme validated by different stakeholders:
- collecting stakeholders' inputs contributing to the IOM/UNFCCC study recommendations on the needs and opportunities for a stronger integration of human mobility in regional and national Green Economy and related policies, plans and frameworks;
- collecting stakeholders' inputs contributing to the UNHCR study on what protection frameworks and coordination mechanisms for implementation exist to respond to human mobility related to climate change and disasters in the IGAD region;
- increased understanding of how partnerships with private sector actors could enhance climate action in the IGAD region;
- increased understanding of the regular migration opportunities.



4. Structure, format and participation

Virtual forums

- o The partners will organize three virtual consultative forums each forum having a particular focus area.
- o The consultative forums will be conducted via **Zoom platform** and each will take ~ two hours.
- o The consultative forums will be hosted jointly by IOM and UNFCCC with moderation and inputs from Participating UN Agencies: ILO, UNHCR and partners IGAD Secretariat.
- o Participatory methods will be utilized: breakout rooms; whitepapers/murals, quizzes...

Survey

o Invitees and other stakeholders will be able to share their perceptions before some of the (see below) consultative forums through a brief online survey, which will be utilized for preparations of the sessions but will also offer an opportunity for the stakeholders to share their views in a situation where participation in the virtual session is unfeasible.

Consent

- o Participation in the forums is voluntary. Sessions will be recorded. By participating, the participants accept that the events will be recorded for the purpose of the organizers; the recordings will not be published.
- o The information shared in the consultative forums will be utilized also to collect data for the relevant studies. However, all information will be anonymized. By participating in the event, permission to utilize the information for the study purposes will be granted.

Language

o The consultative forums will be run in English for all sessions.

Participation

- o Practitioners in the field of human mobility, climate change action, disaster risk reduction, protection, representatives of international organizations, national and regional partners and focal points.
- o Member States, International organizations, non-governmental organizations, private sector, academia, trade unions, employers organizations.
- o Key stakeholders will be welcomed to join the virtual consultative forums through an invitation. The invitations will be shared via email. However, the sessions are open to all who are interested and have a stake in the topics.

Registration

o Partners will be asked to register in advance.

Final results sharing



- o The final findings and recommendations of the on-going studies will be presented in the Africa Climate Week 2022.
